Program Committee News

ANS 2009 Annual Meeting, Atlanta, GA

The 2009 Annual Meeting was held in Georgia, GA, (June 14-18). A total of 42 papers were presented in 5 sessions.

In addition to our standing sessions (Reactor Physics General – 6 papers, Reactor Analysis Methods – 9 papers and Reactor Physics Design, Validation and Operating Experience – 6 papers), two special sessions were organized: Advances in Small and Medium Sized Reactor Designs (organizers Youssef Shatilla and Pavel Hejzlar – garnering 16 papers!), and Recent Progress and Applications of Resonance Calculation Methods (organizer: Akio Yamamoto – 5 papers).

Best Paper Award (ANS 2009 Annual Meeting)

Based on the scores provided during the paper review process, selection was narrowed down to four papers to be considered for the RPD Best Paper Award at the ANS 2009 Annual Meeting. A panel of judges attended the presentations, and selected the paper entitled "A New Framework of Resonance Calculation Method based on the subgroup Method" by Akio Yamamoto, Hiroki Koike and Yoshihiro Yaman (Nagoya University). Congratulations to the authors and appreciation to the judges!

ANS 2009 Winter Meeting, Washington, DC

Please plan to attend the upcoming ANS 2009 Winter Meeting in Washington D.C. (November 15-19), and the RPD sessions in particular. We have a total of 41 papers in 5 sessions plus one panel: Experiences with International Collaborations in Nuclear Engineering Research and Educational Exchanges (organizers: Ivan Maldonado and Pavel Tsvetkov). Thanks and congratulations to the session and panel organizers for their usual effort.

The Honors & Awards Committee unanimously selected Professor Edward Larsen, of the University of Michigan, to be the 2009 winner of the *Eugene P. Wigner Reactor Physicist Award*. Prof. Larsen will deliver the Wigner Lecture on Tuesday morning during the technical session on Reactor Analysis Methods. His topic will be *"Asymptotic Analysis in Nuclear Reactor Theory"*. The Wigner plaque will be presented to Prof. Larsen during the Tuesday Honors and Awards Luncheon.

ANSI/ANS-19.10, "Standard for Calculating Pressure Vessel and Reactor Internals Neutron Fluence" has been released as an American National Standard. Revisions are nearing completion for three ANSI/ANS standards: ANSI/ANS-19.1, "Nuclear Data for Reactor Design Calculations; ANSI/ANS-19.3, "American National Standard for Steady-State Neutronics Methods for Power-Reactor Analysis" and ANSI/ANS-19.6.1, "Reload Startup Physics Tests for PWRs".

ANS-19, the Reactor Physics Standards Committee, seeks qualified people for the various working groups within the committee. Activities encompass all major areas in reactor physics.
